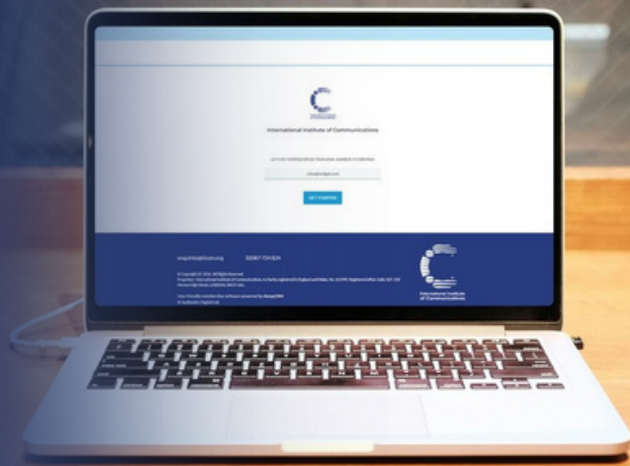


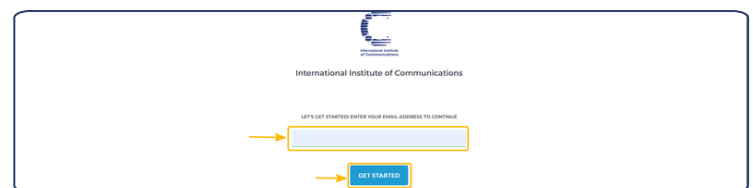
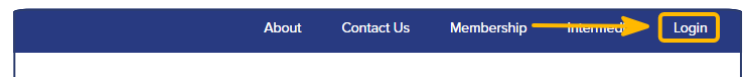


How to register for your IIC account

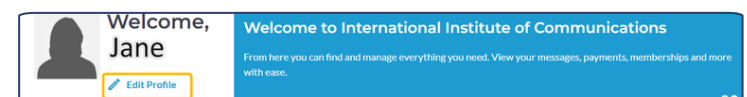

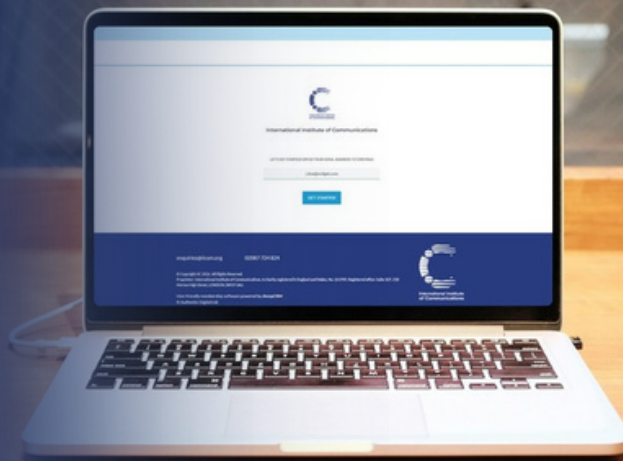
